Haddonfield Civic Association records, 1911-1992 (bulk 1912-1987) Collection #2015-059

ABSTRACT:

The Haddonfield Civic Association was established in 1911 as a non-partisan, all-male organization dedicated to "the Promotion of Civic Pride and the Betterment of this Town's Welfare." This collection includes the Civic Association's records from 1911 to 1992, including correspondence, meeting minutes, newsletters, and other organizational documents. Major subjects include the Civic Association's efforts to preserve Haddonfield's historic character, its effort to "colonialize" the business district, its activities during the Great Depression and World War I, and local controversies about taxation, school improvement proposals, and zoning and development.

BIOGRAPHICAL / HISTORICAL BACKGROUND:

The Haddonfield Civic Association was established in 1911 as a non-partisan organization dedicated to "the Promotion of Civic Pride and the Betterment of this Town's Welfare." Its first president was Frank A. Smith, and its expansive focus can be seen in its inaugural committees: Civic Pride, Education, Health, Law and Order, Membership, Municipal Affairs, Public Utilities, and Publicity.

The Haddonfield Civic Association has long encouraged community involvement: urging Haddonfield residents to vote in elections, attend public meetings on municipal matters, and support community resources like schools and the public library. It also played a major role in the "colonialization" of the business district and the establishment of Haddonfield's historic district, among other accomplishments.

Established as an all-male organization, the Civic Association did not admit women until 1972, and maintained a friendly rivalry with the Haddon Fortnightly, a women's civic and social club in Haddonfield. In 1922, the Civic Association and the Haddon Fortnightly jointly purchased Artisans Hall (301 Kings Highway East, Haddonfield). In 1931, the Civic Association sold its share of the building to the Fortnightly, which continues to use it as a meeting place.

The Civic Association has hosted an annual Haddonfield Town Dinner since 1911, first at Artisans Hall, and in more recent years at Tavistock Country Club. In 1927, the Civic Association began holding an annual Robert Bradshaw Memorial Essay Contest for senior boys (now open to all seniors), named for the Civic Association's 1920-1925 president.

SCOPE AND CONTENT NOTE:

This collection includes the organizational records for the Haddonfield Civic Association from its founding in 1911 until 1992, including meeting minutes, correspondence, and other organizational documents, as well as news clippings about the Civic Association and its activities. The collection is generally arranged by type of record, with some special topics like the proposed Cross County Freeway and Kings Highway Beautification arranged in separate folders.

The Association's meeting minutes range from 1911 to 1992 and are recorded in bound ledgers. The minutes also include lists of the Board of Governors members, committees, and treasurers' reports.

The correspondence files, dating from 1912 to 1979, provide a deeper picture of the Civic Association's work. A major theme in these files is the Civic Association's effort to preserve Haddonfield's historic character by collaborating with the Shade Tree Commission, advocating the establishment of the Historic District, and campaigning against liquor licenses and high-rise developments. Another major theme is the Civic Association's promotion of community engagement, as demonstrated by its support for the public library, the community pool, and a proposed youth center. The Civic Association also encouraged citizens to vote in all elections and to attend town meetings, and publicized elections and other political events through mailers and advertisements in the local paper. Other subjects of interest include civilian activities during World War I, establishment and improvement of Haddonfield public schools, and relief efforts during the Great Depression.

The "Reporter" newsletters provide useful summaries of the Civic Association's accomplishments and activities from 1954 to 1977.

The Town Dinner file contains the programs for the 1920-1987 dinners, where the Civic Association hosted various speakers and honored individuals and organizations for their service to the community.
